## **Position Description**

The Institute for Public Strategies (IPS) is seeking a **full-time LA County Community Engagement Coordinator** for a program that focuses on preventing exposure to tobacco and marijuana smoke in multi-housing units and outdoor areas in East Los Angeles (specifically, the communities of Alhambra, Montebello, Pico Rivera, and Whittier) through community engagement, coalition building, and policy change. This position requires a creative problem solver who can manage details without losing sight of the big picture. The candidate must work well as part of a diverse team with divergent ideas and work styles. This at-will, grant-funded position is based out of Culver City, CA, but requires significant travel and commute to our East Los Angeles communities, with opportunities for extensions contingent upon funding.

## **ESSENTIAL FUNCTIONS:**

- 1. Understanding of environmental prevention strategies to reduce alcohol, tobacco and other drug problems;
- 2. Engaging in community outreach and engagement initiatives through efforts including, but not limited to: community tabling events, community presentations, planning small/large scale outreach events, meetings with key stakeholders/city officials, public comment, door-to-door outreach, and community surveying;
- 3. Assist with development, implementation, and coordination of project activities and educational trainings to be administered in community settings;
- 4. Provide leadership to a community coalition, including conducting recruitment and engagement;
- 5. Design and develop various publications with visual representations of data using graphic design tools such as Power Point. Canva and Illustrator:
- 6. Manage social media strategy on multiple platforms, including website, as part of a comprehensive media advocacy and community organizing plan;
- 7. Participate in Smoke-free Multi-Unit Housing and Outdoor Areas workgroup, training, and TA sessions;
- 8. Provide topic-specific summaries of research, literature reviews, and evidence-based strategies to support public policy and media advocacy;
- 9. Translate technical reports, research papers, statistics, public policy, and institutional policy to laypersons;
- 10. Maintain Excel database of key data sources and indicators, develop progress reports;
- 11. Work periodic weekend and/or evenings, including travel;
