This position requires a creative problem solver who can manage the details without losing sight of the big picture. The candidate must work well as part of a diverse team with varying ideas and work styles. This position is based out of Culver City, CA, and serves the City of West Hollywood as well as other communities within the Service Planning Area (SPA) 4.

## **ESSENTIAL FUNCTIONS:**

- 1. Manage staff as direct reports, and take on supervisorial duties (such as approvals, timecards, etc)
- Supervise a team—Oversee alcohol and other drugs (AOD) primary prevention and harm reduction initiatives, including
  research, data collection and analysis, high school and college-age youth engagement, coalition building, community organizing,
  and capacity building.
- Oversee the execution of all work plan deliverables according to predetermined timelines
- 4. Oversee and participate in day-to-day environmental prevention programs and services across our West Los Angeles service planning area, including (but not limited to): conducting data/research initiatives; leading a community coalition; planning small and large-scale community outreach events; hosting educational workshops, and supporting policy initiatives
- 5. Conduct and lead programmatic activities that align with the Spectrum of Prevention and Strategic Prevention Framework (SPF)
- 6. Oversee the implementation of evidence-based strategies and prevention concepts to address substance use/misuse in the West Hollywood community
- Oversee the recruitment, onboarding, and management of college-aged or older interns
- 8. Facilitate the planning and execution of two to three annual "sober third space events," including applying for and securing funding, event planning work such as hiring talent and caterers, and incorporating SUD prevention education into the event.
- Oversee partnerships with county agencies, service providers, community leaders, elected officials, law enforcement partners, and other key stakeholders to empower residents in developing and implementing equitable policies that prevent substance use/misuse, especially in underserved neighborhoods

Lead and engage in upstream substance-use advocacy and policy efforts, including (but not limited to: developing policy briefs; drafting community ordinances; collaborating with legislators, policymakers, and key stakeholders; advocating for policies and reforms at the local, state, and federal levels; and identifying funding opportunities and partnerships to support systems change initiatives.)
